## INFORMATION SHEET FOR REGISTRATION TO THE CONSULAR FILE

Remove a "Consular File Registration Form" and the "Declaration on Honour" from the Directorate General or the Secretariat of the IDED (the Information, Documentation and Economic Development Center in Business Developments Directorate of Commonwealth Business);

Fill them out (Note that the Declaration of Honor is done on the letter head of your Society).

Have the declaration made on the honor by the competent authority; Pay 25 000 FCFA to the Information, Documentation and Economic Development Center in Business Developments Directorate (a IDED) – Patent of the current year (TAX) – Commercial Register (Court Registry) – Taxpayer's card (Taxes) – Status of the Company in case of SA or SARL –Company Location Map-Letter Head.
